The Program Fee is a total amount paid for housing, transportation, international airfare, entrance fees, insurance and some meals. This Program Fee is paid through CNU STUDENT ACCOUNTS via CNU LIVE. Instructions will be sent to you upon acceptance to the program.

Students will also be expected to have spending money available in-country for meals and personal expenses in their free time. Students should discuss with the faculty leaders or the study abroad office to determine an estimate of out-of-pocket expenses.

## **Payment Schedule for Program Fee**

*\*Fuel Surcharges, exchange rate fluctuation and/or inflationary conditions may necessitate that the program raise fees above the previously advertised rates between the time of acceptance and the beginning of the program.*

## **Payment amounts & Deadlines:**

**October 31, 2019 - Deposit- \$500\*\***

**December 1, 2019 - First Program Fee Payment - \$1,000**

**January 31, 2020 – Final Program Fee Payment - \$1,100**

*\*\*The deposit will hold your space in the program. Once accepted to the program, the spaces will be filled first come first serve.*

## **Tuition & Fees**

The Study Abroad Office will register you for SOCL 395 for 1 credit. This will count as one of your spring semester credits.

## **Refunds and Withdrawal Policy**

Payments are made to vendors to secure services on behalf of the students in advance of travel and are often non-refundable to CNU. These expenses may include but are not limited to pre-paid meals, pre-paid room or housing reservations, airline deposits or tickets, bus rental fees, etc. Thus, even if you withdraw from the program before the departure, you are still responsible for unrecoverable program costs.

- If a student withdraws from program on or before **December 1, 2019**, the deposit may be refunded to the student.
- If a student withdraws from program after **December 1, 2019**, the deposit will not be refunded.
- The first and second payments are non-refundable payments.
- For CNU study abroad programs, “withdrawal” includes voluntarily withdrawal as well as involuntarily withdrawal due to illness or other circumstances, or if the student is dismissed or suspended from the university for either academic or conduct reasons. If a student is dismissed from the program for academic or conduct reasons after the program begins, or if the student voluntarily withdraws from the program after it has begun, there will be no refund issued to the student for fees that have been charged.
- If the program is cancelled due to insufficient student enrollment, then all charges will be refunded.
- If the program is cancelled due to an act of war or terrorism, a State Department warning or other circumstances that make the program location unsafe, all fees not already spent on behalf of the student will be refunded.

- All withdrawals, as well as any requests for refunds should be made in writing to the Study Abroad Office prior to the dates noted above. It is in the student's best interest to notify the study abroad office immediately upon making a decision to withdraw.
- If a student elects or is unable to participate in one or more individual program activities (field trips, group meals, etc.), the cost of these activities cannot be refunded.
