Two types of payments are made for CNU Study Abroad Programs before departing the United States. Students will also be expected to have spending money available in-country for meals and personal expenses in their free time. Students should discuss with the faculty leaders or the study abroad office to determine an estimate of out-of-pocket expenses. Payment types:

1. **The Program Fee** is a total amount paid for housing, transportation, international airfare, entrance fees, insurance and some meals. This Program Fee is *paid* through CNU STUDENT ACCOUNTS via CNU LIVE. Instructions will be sent to you upon acceptance to the program.
2. **Tuition & Fees** is the cost of the academic credit taken during the study abroad. Tuition & Fees are *charged* to CNU STUDENT ACCOUNTS via CNU LIVE after the program fee has been collected in full. Charges will be placed onto your account by CNU in the spring.

## **Payment Schedule for Program Fee**

**Program Fee Total = \$3,600\***

*\*Fuel Surcharges, exchange rate fluctuation and/or inflationary conditions may necessitate that the program raise fees above the previously advertised rates between the time of acceptance and the beginning of the program.*

## **Payment amounts & Deadlines:**

**October 20, 2024 – Deposit - \$1,000\*\***

**December 1, 2024 - First Program Fee Payment- \$1,200**

**January 31, 2025 – Final Program Fee Payment - \$1,400**

**Mid-April – Tuition Payment Due: See below for amount**

**\*\*The deposit will hold your space in the program. Once accepted to the program, the spaces will be filled first come first serve.**

## **Refunds and Withdrawal Policy**

Payments are made to vendors to secure services on behalf of the student in advance and are often non-refundable to CNU. These expenses may include but are not limited to pre-paid meals, pre-paid housing, airline deposits or tickets, bus rental fees, etc. Thus, even if you withdraw from the program prior to departure, you are still responsible for unrecoverable program costs.

- If a student withdraws in writing from program on or before **November 23, 2024** the payments may be refunded to the student.
- If a student withdraws from program in writing after **November 23, 2024**, the payments collected will not be refunded.
- For CNU study abroad programs, “withdrawal” includes voluntarily withdrawal as well as involuntarily withdrawal due to illness or other circumstances, or if the student is dismissed or suspended from the university for either academic or conduct reasons. If a student is dismissed from the program for academic or conduct reasons after the program begins, or if the student voluntarily withdraws from the program after it has begun, there will be no refund issued to the student for fees that have been charged.
- If the program is cancelled due to insufficient student enrollment, then all charges will be refunded.

### **Refunds and Withdrawal Policy Continued:**

- If the program is cancelled due to an act of war or terrorism, a State Department warning, Centers for Disease Control and Prevention warning, or other circumstances that make the program location unsafe, all fees not already spent on behalf of the student will be refunded.
- All withdrawals, as well as any requests for refunds should be made in writing to the Study Abroad Office prior to the dates noted above. It is in the student's best interest to notify the study abroad office immediately upon deciding to withdraw.
- If a student elects or is unable to participate in one or more individual program activities (field trips, group meals, etc.), the cost of these activities cannot be refunded.
